**This articulation agreement has been specially designed to fully accommodate graduates in A.A.S. degree programs.**

### **Purpose**

The purpose of this agreement is to facilitate credit transfer and provide a smooth transition for students in the A. S. Criminal Justice – Corrections, A.S. Homeland Security, and A.A.S. Criminal Justice - Police degree programs at SUNY Broome Community College into the B.T. Criminal Justice degree program at Morrisville State College.

### **Agreement**

This agreement applies to transfer students who have completed the A. S. Criminal Justice – Corrections, A.S. Homeland Security, and A.A.S. Criminal Justice - Police degree programs at SUNY Broome Community College, received an Associate's degree, and meet admissions standards at Morrisville State College.

This agreement recognizes that the Associate degree programs at SUNY Broome Community College are consistent with the first two years of study at Morrisville State College and the combination of required coursework is in keeping with Morrisville State College transfer policies to grant full junior status.

Specific courses listed on the subsequent page are required to ensure proper alignment.

This Transfer Pledge is our partnership with you in recognition of the high quality of your graduates. We pledge to provide an exceptional educational value by providing your students with the classes needed to complete a baccalaureate degree in four additional semesters. In addition, your graduates are eligible for a guaranteed preferred housing scholarship for four consecutive semesters.

### **Admissions Requirements**

Students transferring into Morrisville State College must have a minimum cumulative grade point average of 3.0 at the time of admission. Students must submit the SUNY Application as well as all college transcripts for review by the Morrisville State College Admissions Office.

### **Transfer Promise Program Requirements**

Students must be enrolled in four full-time consecutive semesters, must maintain satisfactory academic standing, remain in good judicial standing, and successfully complete all classes in sequential order as advised.

### **College Graduation Requirements**

Please refer to the attached program guide sheet for requirements. Transferring students will be required to complete four consecutive semesters with a minimum of 60 credit hours of successful coursework at Morrisville State College, and meet College residency requirements. A minimum of 120 credit hours must be earned and a 2.0 minimum grade point average is required for graduation.

### **Articulation Implementation and Agreement Review**



One administrator or faculty member from each institution will be appointed to act as agents responsible for implementing this agreement; identifying and incorporating any changes into subsequent agreements; communicating changes to prospective faculty members, advisors, counselors, and others to whom the information is pertinent; and for conducting a periodic review of this agreement.



### SUNY Broome AS in Corrections / Morrisville State College BT in Criminal Justice

**Background:** The purpose of this proposal is to develop an articulation agreement between our two institutions that would allow students who successfully complete the SUNY Broome AS in Corrections to complete the MSC BTech in Criminal Justice in four semesters of full-time study, including one semester of full-time internship.

While we will make some recommendations about what courses students should take as SUNY Broome electives in order to have the easiest possible transfer to our BTech, we realize that it will not be possible in every case to be totally certain what courses SUNY Broome students will be bringing. We will try to be as flexible as possible. For the sake of this sample transfer framework, we have assumed that the SUNY Broome student has taken as electives a SUNY Broome course that is the equivalent of our COMP 102, the SUNY Broome equivalent of our Introduction to Sociology, and a course that can be accepted as a required elective in Criminal Justice. To the extent that SUNY Broome students transfer to Morrisville elective credits that can be applied to degree requirements (i.e. are in the field of criminal justice or meet SUNY General Education requirements), we will make every effort to assure their degree completion in four full-time semesters.

This agreement would apply only to students who complete the AS degree at SUNY Broome before transferring to Morrisville State.

### SUNY Broome AS in Homeland Security /Morrisville State College BT in Criminal Justice.

**Background:** The purpose of this proposal is to develop an articulation agreement between our two institutions that would allow students who successfully complete the SUNY Broome AS in Homeland Security and who take recommended elective courses while at SUNY Broome to complete the MSC BTech in Criminal Justice in four semesters of full-time study, including one semester of full-time internship.

We note that the SUNY Broome curriculum includes two “Program Electives” and one “General Elective.” While we will make some recommendations about what courses students should take as SUNY Broome electives in order to have the easiest possible transfer to our BTech, we realize that it will not be possible in every case to be totally certain what courses SUNY Broome students will be bringing. We will try to be as flexible as possible. For the sake of this sample transfer framework, we have assumed that the SUNY Broome student has taken as electives the SUNY Broome equivalent of our Introduction to Sociology, the SUNY Broome equivalent to our Penal Law, and a course that can be accepted as a required elective in Criminal Justice. To the extent that SUNY Broome students transfer to Morrisville elective credits that can be applied to degree requirements (i.e. are in the field of criminal justice or meet SUNY General Education requirements), we will make every effort to assure their degree completion in four full-time semesters.

This agreement would apply only to students who complete the AS degree at SUNY Broome before transferring to Morrisville State.
