5.0 INFORMATION ITEMS

5.1 **President's Report – Dr. Kevin Drumm**

Dr. Drumm thanked the immediate past Chair Anthony Paniccia for his service to the college. Trustees Testani, Fiala, and Coffey all attended the NYCCT Conference. Trustee Coffey was voted onto the NYCCT Board. Dr. Drumm attended the Presidential Honors Scholarship (PHS) event. This was the largest number, (19) of incoming freshmen. October 20 will be the dedication of the Battisti Pergola. Enrollment is incrementally improving and is at a 2.8% decline. The FA and the college have a tentative contract agreement. Dr. Drumm just returned from the NACCE meeting in Boston.

5.2 College Assembly – Erin Marulli

Ms. Marulli reported on the highlights in her report. A copy was included in the board packet. A Your Voice Matters is scheduled for November 10. The College Assembly

endorsed the role of the Civic Engagement Coordinator. There will be a vote on the proposed Shared Governance restructure from 4 units to 3 units on October 17th.

5.3 Student Affairs – Dr. Carol Ross-Scott

This month's Student Affairs report is focused on Health & Safety. Mr. Nick Brey – Director of Campus Safety & Security reported. Mr. Brey reported staff of Public Safety is encouraged to interact with the community to promote a positive report with students and staff. They attend Criminal Justice classes and also helped out on Move-In day. Students must have an initial COVID vaccine regimen and information is uploaded to the SUNY portal. Religious and medical exceptions must still be submitted and reviewed. Public Safety is working with Facilities to upgrade the locks on building room doors in cases of emergency, one can barricade themselves inside the room. The goal is to have all buildings on campus have this capability.

5.4 Student Assembly Update – Elle Yatsuk

Ms. Yatsuk reported on the highlights in her report. A copy was included in the board packet. The Student Assembly has 1 open position left. Many activities are being held on campus and increasing student engagement. The SA passed a resolution to require equal student representation on the Convocation Committee. The SA worked with American Dining on vending machine issues. Ms. Hodel from Financial Aid spoke to the group about Residency Certificates that are needed every semester.

5.5 **BCC Foundation Report – Cathy Williams**

Ms. Williams reported on the highlights in her report. A copy was included in the board packet. The magazine is at the printers and will be sent out. The 24 Hours of Giving is Tuesday, November 29, 2022. The Foundation is partnering with the Veterans & Military Affairs office to host the Twin Tier Honor Flight homecoming on Sunday, October 16, 2022, at 6 p.m. October 20 will be the dedication of the Battisti Pergola. This year marks a record number of incoming freshmen (19) who received the Presidential Honors Scholarships.

5.6 Facilities Update – Dave Ligeikis

Mr. Ligeikis reported on the highlights in his report. A copy was included in the board packet. Photos of the 2 of 3 pavilions and also of the Battisti Pergola were shared with the group. Work is nearing completion on the Library roof. New SUNY Broome banners will be installed on the light poles on the Campus Loop road and all parking lots. The 2021-2022 campus paving and sidewalk contract has been completed. Preliminary design work continues to develop an on-campus track and field facility. Construction documents have been completed for campus HVAC projects in multiple buildings.
