5.1 **President's Report – Dr. Kevin Drumm**

Dr. Drumm thanked the Trustees for their time. The college held the Annual Campus Holiday party on December 8 at the CEC. The community is very impressed with the renovation. The Student Assembly hosted the annual Giving of the Toys that morning. Dr. Drumm attended semester year-end events with the Music and Engineering Programs. Dr. Drumm had a lengthy conversation with Senator-Elect Lea Web and the new Chancellor elect King who is reaching out to all the Presidents. Enrollment remains positive with the number of applications and inquiries increased from last year's spring semester. The Nursing Department is hosting its Pining Ceremony tonight. On January 18, the SPARK project will be held on campus for local area 8th-grade school students. Curtailment starts at the end of business December 23 – January 2nd with the college reopening on Tuesday, January 3, 2023.

5.2 **Council on Operational Issues – Brittany Richardson**

Ms. Richardson discussed the highlights of her report. A copy was included in the packet and is for informational purposes. COI supported the Civic Engagement position and resolved 2 issues submitted through Your Voice Matters. Shared Governance chairs are rotating and attend the Student Assembly meetings.

5.3 Academic Affairs – Dr. Penny Kelly

Dr. Kelly introduced Dr. Christina Martey-Ochola, Interim Dean of STEM. Dr. Kelly presented updates on the sustainability plan. The expanded BU BAP program expects to have 50 more BU students in the Fall of 2023. The BU Pharmacy School and Broome are working on collaborations and articulations. Workforce Development is developing collaborations like the Build Back Better initiative. Fast Forward is being reimagined. The Nursing Program is expanding its evening/weekend programs. The Decker Health Sciences Nursing Department will be renovated starting in July 2023 through Fall 2024.

A quorum was established and the meeting returned to Agenda Item #1 – Item #4. The meeting resumed Information Items after Agenda item 4.2 was voted on.

5.4 Student Assembly Update – Elle Yatsuk

Ms. Yatsuk reported on the highlights in her report. A copy of the report was included in the Board Packet. Student Assembly meetings will be held at 4 p.m. on Fridays in the Spring semester. All executive spots have been filled. There are many student activities planned for the spring semester.

The cover story features Peter Vallese '49. The baseball field will be dedicated to Edwin Daub in April at the Alumni Reunion, April 28-29, 2023.

5.6 **Facilities Update – Dave Ligeikis**

Mr. Ligeikis reported on the highlights in his report. A copy of the report was included in the Board Packet. The Library roofing project is complete. Bids have been received for the HVAC project for the Library and Business Buildings. Contracts are being reviewed for the Decker Nursing renovation project. New banners have been installed on the light poles in the parking lots and loop road. To enhance safety, new interior door locks will be installed in all classrooms, labs, common areas, and offices.
