Chair Barbara Fiala called the meeting to order at 5:01 p.m. She thanked immediate past chair Kathy Connerton for her leadership and presented her with a cake and flowers.

1.0 INFORMATION ITEMS

1.1 President's Report – Dr. Tony D. Hawkins

Dr. Hawkins thanked past Chair Connerton for her leadership. This is Domestic Violence Awareness Month. Dr. Hawkins acknowledged the new Assistant Vice President and Dean of Students Dr. Scott Kane. Dr. Hawkins introduced his new Executive Assistant Maureen Breck and thanked Diana Lenzo for covering the Board meetings until his new assistant was found. Dr. Hawkins thanked the trustees for attending his Inauguration, there were close to 300 attendees. He thanked Trustee Fiala, Connerton, Andrews, and Khan for speaking. Dr. Hawkins attended the NYCCT Conference with Trustee Khan. The main conversation at the conference was about the SUNY system and its role in hiring and evaluating community college presidents. A big topic was Trustee advocacy and the state budget. The college is working on improving the campus climate based on the feedback from the employee satisfaction survey. Consistent with the feedback, the focus will be on rules and policies, change in management, and kindness and civility. October 10 was World Mental Health Day. Dr. Hawkins attended the CASE conference with Cathy Williams. October 13 is the College Open House, and October 23 is the Presidential Honors Scholarship. The college will be recognized at the upcoming Continuing Education conference with awards for the Lineman program and Health Sciences. Danielle Britton will be honored with the Experienced Educator Program Award.

1.2 College Senate – Erin Marulli

Ms. Marulli reported on the highlights in her report. A copy was included in the packet. The new Shared Governance structure and constitution have been approved and the college website updated. The new college Civility Statement was reviewed and edited. Shared Governance held a kick-off event to bring awareness of the group to the college community. SUNY Online was presented at the College Senate. Nominations for the Chancellor Awards are now being accepted.

1.3 Student Affairs – Dr. Carol Ross-Scott

Dr. Ross-Scott reported on the highlights in her report. She reported that the Student Assembly has a full complement for the fall with 3 EOP students. The Old Sciences Building is full of activity with new Student Assembly offices on the 1st floor. The Student Village housing

refinancing project is completed. She thanked VP Sullivan and the Finance team for their hard work on the project. Dr. Ross-Scott introduced Housing Director Evan Bigham, who presented at the Student Village.

1.4 Student Assembly Update – Hiba Khan

Trustee Khan announced that the Student Assembly is full this year and committees are being established. The Assembly now has new office space. Trustee Khan volunteers with local election campaigns and enjoys getting involved in the community and voter registration.

1.5 **BCC Foundation Report – Cathy Williams**

Ms. Williams reported on the highlights in her report. A copy was included in the packet. Fundraising appeals have started. This will be the 10th anniversary of Giving Day. The latest edition of the Broome Magazine has been distributed. The spring 2024 edition had a record number of engagements online. She thanked MARCOM for their work. There were 16 new recipients of the Presidential Honors Scholarships. There was some confusion from an announcement of the Foundation's Annual Meeting and voting rights for the trustees. Ms. Williams explained that the Trustees and VPs are considered ex officio members of the BCC Foundation and will continue to receive notices of the annual meeting.

1.6 Facilities Update - Dave Ligeikis

Mr. Ligeikis reported on the highlights in his report. A copy was included in the packet. The transition of the Old Science Building to a Student Union continues with new offices for the Student Assembly on the first floor. The Executive Council met with architects to discuss the library becoming a one-stop shop and to start the RFPs for design. Mr. Ligeikis's report provided the savings from the HVAC upgrades. The resolutions for the Decker Nursing project bid results are on the agenda for approval. Anticipated completion is August 2025. Phase 1 of the Campuswide signage project is going out to bid. The county is constructing a safety crosswalk from the campus to the softball fields. Parking will be allowed on the campus for softball games.
