If you are unable to sufficiently validate your identity in order to use the on-line, real-time access to your IRS documents, you may request Tax Return and Tax Account Transcripts be sent to you via US mail. For W-2's (Wage & Income Transcript) and the Verification of Nonfiling: if you are unable to validate your identity by using the Get Transcript ONLINE, you must complete and submit the IRS Form 4506-T.
