

# ARTICULATION AGREEMENT

SUNY Broome Community College

Dental Hygiene, A.A.S.

and

Pennsylvania College of Technology

Dental Hygiene, B.S.

## I. PURPOSE

This agreement establishes a mechanism for graduates of the Dental Hygiene, A.A.S. major SUNY Broome Community College to transfer specific earned credits into the Dental Hygiene, B.S. at Pennsylvania College of Technology.

## II. GOALS

- A. To provide a well-defined mechanism for graduates of the Dental Hygiene, A.A.S. at SUNY Broome Community College to begin the Dental Hygiene, B.S. at Pennsylvania College of Technology at the appropriate entry point.
- B. To recruit associate-degree graduates whose career goals include acquisition of a baccalaureate degree.

## III. ADMISSION PROCEDURES

- A. Students must submit a completed application for admission, satisfy tuition deposit, and placement testing. The application fee will be waived if the application is submitted electronically.
- B. Students must provide an *official* transcript of all college course work.
- C. Pennsylvania College of Technology will only consider those credits earned through SUNY Broome Community College. Students must request transcripts from additional institutions to be evaluated on an individual basis at Pennsylvania College of Technology.
- D. The student's academic profile, a prescribed course sequence for completion of a specific major, will be provided after official evaluation of all transfer credit. The academic profile will determine graduation requirements.
- E. General Education requirements will be evaluated on an individual basis through official transcript evaluation.
- F. Students transferring to Penn College are eligible and will be considered for scholarship opportunities the same as currently enrolled students. Students must meet the application deadlines for scholarships for the fall and spring enrollment. Students must have paid the tuition deposit to be eligible.

#### IV. TRANSFER REQUIREMENTS

Pennsylvania College of Technology will accept SUNY Broome Community College graduates into the Dental Hygiene, B.S. program if they meet the following requirements and adhere to admissions and program procedures.

- A. Applicants must have a final cumulative GPA of 2.0 (on a 4.0 scale) or higher. All courses eligible for transfer must be completed with a "C" or higher.
- B. Dental Hygiene related courses will transfer as a block, and will not be evaluated individually. The block transfer requirement will be contingent upon health care credential completion. The transfer block consists of a maximum of 44 credits.

#### V. PROGRAM REQUIREMENTS


- A. Complete a minimum of 36 credits at Penn College for course work prescribed in the final four semesters (spring and fall) of a student's profile. The calculation will include credits for any summer course work required within or after the final four semesters.
- B. As soon as the credential is earned, or before petitioning to graduate, students must present a photocopy of the current (not expired) health care credential as noted above to be eligible for the respective block of credits.
- C. Students may complete all required credits on a full-time or part-time basis.
- D. The credits for the health care credential will be applied to Penn College's graduation requirements.


#### VI. SIGNATURES
