

Articulation Agreement Between

Farmingdale State College, a Campus of the State University of New York

and

Broome Community College, a Campus of the State University of New York

This articulation agreement is intended to facilitate the transfer of graduates from Broome Community College's Dental Hygiene Program to the Bachelor of Dental Hygiene Degree Completion Program at **Farmingdale State College of New York**.

The objectives, terms and conditions of this agreement are set forth as follows:

OBJECTIVES

1. To facilitate upward educational and career mobility in Dental Hygiene by increasing accessibility to bachelor's education for qualified individuals.
2. To reduce unnecessary repetition of general education and curricular content by providing a seamless articulation opportunity.
3. To facilitate communication, academic coordination between faculty, students, and administrators at each institution.

ELIGIBILITY/ ADMISSION REQUIREMENTS

1. Students must graduate with a dental hygiene diploma and be licensed as a Registered Dental Hygienist.
2. Students must complete the admission process.

The terms of this agreement shall commence as of October 1, 2022 and will remain in effect until either party determines that there is a need for change. This agreement will be reviewed on an ongoing basis, and may be terminated by either party with six months prior notice.

Both parties shall inform current and future students of this agreement and shall publicize this information on their websites and have information available to the students.
