AGREEMENT made this 18 day of January202 24 between ADELPHI UNIVERSITY, One South Avenue, Garden City, New York 11530 ("AU") and SUNY BROOME COMMUNITY COLLEGE, 907 Front Street Binghamton NY 13905 ("SUNY BROOME CC").

I. Purpose

This agreement between AU and SUNY BROOME CC provides the terms and conditions for students of SUNY BROOME CC who have an Associate of Science in Sport Studies and seek admission by transfer to the Bachelors of Science in Physical Education at Adelphi University. The parties will use their best efforts to minimize loss of credits and duplication of coursework. Benefits to students noted herein reflect the commitment that AU has to furthering its partnership with SUNY BROOME CC, and its respect for how well-prepared SUNY BROOME CC students are to continue their education at AU.

II. Admission

SUNY BROOME CC graduates seeking admission are required to meet the minimum criteria for admission to Adelphi University. At this time, the University requires a grade point average (GPA) of 2.3 based upon a maximum GPA of 4.0 for admission to the B.S. degree program in Physical Education.

Applicants whose GPA falls below a 2.3 will be given individual consideration on a caseby-case basis. Students shall apply for admission to AU in accordance with rules, policies and procedures of AU in effect at the time of application.

The application fee for AU will be waived for SUNY BROOME CC students who apply.

All students admitted to AU must agree to abide by all applicable laws, regulations, rules, and statutes and all AU policies, rules and regulations, including but not limited to, the codes of conduct and academic and financial policies.

III. Transfer of Credits

SUNY BROOME CC graduates are eligible to receive up to a maximum of 64 transfer credits from SUNY BROOME CC; only graded courses completed with a grade "C-"or higher which meet AU transfer requirements for the applicable AU degree program are eligible for transfer.

To prepare SUNY BROOME CC students to meet with departmental advisors who will determine which courses they will need to fulfill their bachelor's requirements, students may meet with an

admissions counselor in the Office of University Admissions, virtually or in-person, to identify which requirements have been completed. Students may also communicate with an admissions counselor via phone or email if that is the preferred method of contact. Students may also engage the online Transfer Evaluation System (TES) at admissions.adelphi.edu/transfer/transfer-credits.php to access course equivalencies and determine how they will transfer to AU.

Students who complete the Sport Studies (A.S.) degree at SUNY BROOME CC prior to transferring to AU are exempt from taking Adelphi's PATH requirements, subject to their meeting the AU transfer requirements for the AU degree program they are seeking to transfer to.

The PATH requirements are as follows:

- English composition
- Two courses in the arts
- Two courses in the humanities
- Two courses in the social sciences
- One course in natural science
- · One course in mathematics, computing, and logic
- Two courses in oral communication
- One course in written communication
- Two courses in quantitative reasoning
- Two courses in global learning/civic engagement
- One course in information literacy

IV. Scholarships

SUNY BROOME CC students who qualify for admission to AU's degree program in Physical Education (B.S) shall be automatically considered for current Adelphi University merit-based transfer scholarship opportunities upon acceptance.

SUNY BROOME CC students may be required to complete the FAFSA form and provide any other information or applications as the Adelphi University Office of Student Financial Services to be eligible to receive scholarship funds.

V. Registration

SUNY BROOME CC students who have been admitted to AU and have paid their enrollment deposit will be permitted to register during early registration at the same time as their AU counterparts.

VI. Promotion

AU and SUNY BROOME CC agree to cooperate in communicating with each other and with their respective constituents about the relationship between the two institutions. Faculty and staff at both

institutions will share the information provided in this agreement with interested and qualified students. AU and SUNY BROOME CC agree to provide counseling and advisement to students and prospective students about this partnership and the inherent benefits.

SUNY BROOME CC will promote AU in any publications and/or websites that discuss transfer options and agreements, and SUNY BROOME CC's website(s) will have a link to AU. SUNY BROOME CC will also distribute and make available any appropriate AU printed materials. All references to AU will be subject to review and approval by AU.

Each party will designate an individual to serve as a liaison to administer this Agreement. The administrator designated from AU will implement this agreement at AU and communicate changes to those parties at AU to whom the information is pertinent. The administrator designated by SUNY BROOME CC will fulfill the same role for SUNY BROOME CC.

VII. Term of Agreement

This agreement becomes effective on the date of signature by representatives of the institutions reflected below, and may be renewed annually, by mutual consent and agreement. It may be modified or terminated at any time by either institution with written notification and by mutual consent. In the event it is decided at any time to modify or terminate this agreement, commitments made to individual students already in the program will continue in effect for the terms applicable at the time the student enrolled in the program.

Adelphi University and SUNY BROOME CC agree to adhere to the policies to which both institutions are committed concerning equal opportunity and nondiscrimination on the basis of race, creed, color, sex, sexual orientation, age, ethnicity, religion, national origin, or any other classifications that deprive the person of consideration as an individual, with a commitment by both institutions to abide by these principles in administering this agreement, in a manner that assures neither will impose criteria for participation or exchange of scholars or students that violate these principles of nondiscrimination.

VIII. Other Provisions

COMPLIANCE WITH LAWS.

Each Party shall comply with all applicable federal and state laws, codes, rules and regulations in performing its duties, responsibilities and obligations pursuant to this Agreement.

The parties recognize that this Agreement at all times is subject to applicable provisions, as may be from time to time amended, of federal, New York state, and local statutes, rules, and regulations, and policies and/or standards of the United States Department of Education, the New York State Department of Education, and the Middle States Commission on Higher Education. Any provision of law or regulation or judicial or administrative interpretation of same that invalidates, or otherwise is inconsistent with the terms of this Agreement that, in the reasonable judgment of either Party, would cause one or both parties to be in violation of law or regulation shall be deemed

to have suspended the terms of this Agreement; provided, however, that the Parties shall exercise their best efforts to accommodate the terms and intent of this Agreement to the greatest extent possible consistent with the requirements of law and regulations.

INDEMNIFICATION

Neither Party shall be responsible for the acts of the other or for the acts of any student participating in the Program.

SUNY BROOME CC shall defend, indemnify, and hold harmless AU and its officers, trustees, directors, employees, and agents from and against for any and all losses, expenses, damages, and liabilities, including reasonable attorneys' fees, arising out of (a) SUNY BROOME CC's breach of this Agreement; or (b) the negligent acts or omissions of SUNY BROOME CC, its officers, employees, or agents in connection with this Agreement. AU shall defend, indemnify, and hold harmless SUNY BROOME CC and its officers, trustees, directors, employees, and agents from and against for any and all losses, expenses, damages, and liabilities, including reasonable attorneys' fees, arising out of (a) AU's breach of this Agreement; or (b) the negligent acts or omissions of AU, its officers, employees, or agents in connection with this Agreement. This provision shall survive the expiration or termination of this Agreement.

RELATIONSHIP OF PARTIES

The relationship of the Parties to each other arising out of this Agreement shall be that of independent contractors. Nothing contained in this Agreement shall be construed to place the parties in a relationship of partners, joint ventures, employer and employee, or principal and agent. Neither Party is authorized to assume or undertake any obligation of any kind, express or implied, on behalf of the other Party; nor is either Party authorized on behalf of the other Party to make any promise, warranty or representation with respect to such Party.

ENTIRE AGREEMENT/ANNUAL REVIEW.

This Agreement states the entire understanding and agreement between the Parties and supersedes any and all written or oral representations, statements, negotiations, or agreements previously existing. This Agreement will be subject to review by the designated administrators at both institutions on an annual basis to determine if any modifications to the requirements are necessary. Any additions, deletions, or modifications to this Agreement shall not be binding on either party unless accepted and approved in writing by both parties.

This Agreement may be executed in one or more counterparts, each of which will be deemed to be an original, and such counterparts will together constitute the same instrument. This Agreement may be transmitted in electronic format and shall not be denied legal effect because it was formed or transmitted, in whole or in part, by electronic means. An electronic, digital or electronically transmitted signature (collectively, "Electronic Signature") will be deemed an acceptable original for purposes of consummating this Agreement and binding the party providing such Electronic Signature.
